**Call to Order**

President Greg Halpin called a meeting of the Board members of the Old Fire Farts of York County to order at 7:05pm. **Treasurers Report**

Treasurer Bob Straw reported on reports for the period of July 1 through October 2021. Some mistakes were noted with in the reports which Bob will correct. Bob advised also still missing items from past Treasurer Paul Hoover.

**Muster Report**

Kraig Herman reported there were 52 rigs pre-registered, 9 no-shows, 43 on site. Registrations brought in \$940, flea market spaces totaled 15 and brought in \$300. Kraig also reported that had it not been for Fawn Grove Staff doing the on-site and parking, this event could not have happened. There were only 7 Old Fire Farts on site working. For Muster's to continue, more help is needed, especially if we move the Muster back to the York area. Idea of featuring W.S. Darley apparatus in 2022 was mentioned. No action taken.

Kraig has reserved the social hall at Union Fire Co in Manchester (Station 23) for December 4, 2021 for a Joint Christmas Party with the Old Fire Farts. Doors will open at 5pm and we will eat at 6pm. Old Fire Farts will supply baked ham and Kraig will ask if Station 23 can do steamed shrimp. Kraig will coordinate a list of attendees and what covered dish they are bringing between the 2 entities.
